Approval of Last Meeting Minutes

Tom Burrell made a motion to approve the minutes for the 12/19/19 meeting. Jane Lester seconded the motion. With no further discussion and no objection, the minutes were approved.

Finance Report and Budget Discussion

Dean Kate and Charles Winney reviewed the current financials with the group. They are attached. Claude Moulton requested a quarterly balance sheet be included in the financials & Martha Cox requested a summary of Cathedral Builders Fund. Kate opened the floor for discuss on the 2020 budget.

- John Sefton reported sale of YWCA property final proceeds should be determined in the next 6 weeks
- Patricia Young-Jones requested the budget for Outreach Council be increased to \$18,000 from \$15,000. Since
 the council did not use all their budget in 2019, it was suggested they wait until 2021 budgeting planning to ask
 for increase.
- It was suggested Outreach be a focus of the Vestry in February 2020 or at the Vestry Retreat.
- Tom Burrell requested the budget be more detailed, i.e., salaries of clergy be broken down.
- Jane Lester outlined he concerns with the current budget. She feels the repairs to the building are not being addressed in the 2020 budget. She proposes a hiring freeze until June 2020.
- Claude Molten suggested approving a budget without spending any of the Saints Fund.
- Martha Cox addressed the question of building maintenance by suggesting a group be formed to review the
 issue of using the Saints Fund and have them come back to the group with several ideas for the group to
 review.
- Jane Lester made a motion to impose a hiring freeze, with the exception of Forrest Andrews coming on full time and filling the position of Director of Operations, until June 2020. The motion was seconded by Claude Moulton. Discussion of the motion followed: Joe Kincart said a hiring freeze was premature and suggested the Finance Committee be asked to come up with 3 to 5 solutions to balancing the budget without using the Saints Fund. Jayne Barry Hill agreed there should be a strategic overview. The issue is not at a level the motion mentions and the Manager of Stewardship and Development is a vital position. Martha Cox agreed with Jayne and suggested amending the motion. Bruce Barcelo said a hiring freeze could be the most convenient plan but not necessarily the best solution.
- The motion was voted on with 4 in favor, 7 opposed. The motion failed.
- Tom Burrell motion was made to approve the budget as submitted. Joe Kincart seconded. Five were in favor, 6 opposed. The motion failed.

 Martha Cox made a motion to adopt an amended budget with a decrease of \$50,000 in revenue from the Saint's Fund concurrent with a \$50,000 decrease in expenses. Dean Kate would make the decreases and take to the Finance Committee for their approval. Jayne Barry Hill seconded the motion. All voted in favor, the motion was approved.

Fr. Bob Dannals - Organizational Chart

• Fr. Bob Dannals presented a Cathedral Clergy/Staff organization chart. Bob is visiting with each employee and reviewing job descriptions along with having each employee present their personal strategic initiatives at the Clergy/Staff retreat in February. He stated he believes we currently have a moderate sized staff and he plans to make income a priority for the upcoming year.

• Annual Meeting planning is in progress and the Wardens are to present on the behalf of the Vestry.

 - O There was a \$100,000 increase in pledges to bring the total to \$1.37 million since the last meeting in December.




